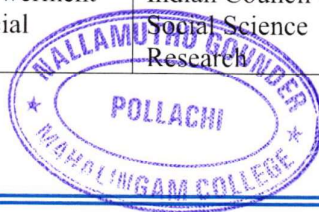



7. **The Third instalment** will be released after receiving second Progress Report (depending on the duration of the programme), simple statement of accounts of the second instalment, along with grant-in-aid bill towards the third instalment.
8. **The fourth instalment** will be released after receiving book length Final Report in soft copy (both word and PDF format), Executive Summary of Final Report in soft copy (both word and PDF format), 500 words abstract of the Final Report in soft copy, research papers published in peer reviewed journals duly acknowledging ICSSR, similarity index score sheet, simple statement of accounts of third instalment along with grant-in-aid bill towards the fourth instalment. Project Director is required to submit hard copies of the Final Report only after the confirmation from the ICSSR after incorporating the suggested changes. Such data or information relating to the research project as may be asked for by the ICSSR for preservation in its Data Archives should be given by the scholar.
9. **The publication grant** will be retained by the ICSSR & will be spent by the ICSSR Publication Division if the Final report is found publishable by an Expert Committee constituted by the ICSSR.
10. The scholar shall acknowledge support of ICSSR in all publications resulting from the project output (Research Paper, Books, Articles, Reports, etc.) and should submit a copy of the same to the ICSSR during its course and after completion.

12. The Overhead Charges to the affiliating institution will be released after the Final Report has been accepted and documents verified by the ICSSR. The ICSSR reserves the right to change the affiliation if it is found that the affiliating institute is not co-operating with the scholar and it is not facilitating timely completion of the study.

14. The University/Institution of affiliation will provide to the scholar office accommodation including furniture, library and research facilities and messengerial services. 17. The Director of the research project will be **Dr. Archana P.** who will be responsible for its completion within **12 Months** from the date of commencement of the project, which is **14 March 2022**, as intimated by the scholar.
18. In case, the Project Director does not submit the periodic / final project report as per schedule with adequate justification, the scholar may be debarred from availing all future financial assistance from ICSSR.
19. All grants from ICSSR are subject to the general provision of GFR 2017.



➤ **Re-appropriation:** The Project Investigator may with the permission of the Institution, re-appropriate expenditure from one sub-head to another, subject to a maximum of 5-7 % of the particular budget heads. With reference to your above cited letter, I am to inform you that the Centre has received the following duly signed documents on the Non-judicial stamp paper
a. Agreement for undertaking the project as per the SRC guidelines, **b.** Declaration form. The other document includes **c.** Undertaking from affiliating University/ College/Institution for administering the project **d.** NOC and **e.** UGC 12B Status of the affiliating University/College/Institution.

In view to this, I am glad to inform you that the ICSSR, Southern Regional Centre has accorded approval for the sanction of the Short Duration Research Project entitled "**Mapping the Livelihood Vulnerabilities of Women Informal Workers in Coimbatore District During COVID – 19**". The Centre sanctioned an amount of Rs.52,500/- (Rupees Fifty Two Thousand and Five Hundred only) to meet the expenditure for undertaking the Research Project under the financial year 2022-23.

The financial assistance should be utilized for the purpose for which it has been sanctioned. No part of the grant is to be utilized for any other purpose.

1. Duration of the Project

The Project Director shall have to complete the Research Project within **a period of 6 months** from the date of award.

The following are the terms and conditions for undertaking the Project:-

2. Joining and Rules of Grant

The sanctioned grant will be released to the Project Director in **Three installments** i.e., 50%, 30% & 20%. The Cheque will be issued in the name of the **Principal of the College.**

(i) Release of First Installment

The First Installment (50% of the grant) is released on receipt of **a)** Grant-in-aid Bill and **b)** Bank details form (copies enclosed).

(ii) Release of Second Installment

The Second Installment (30% of the grant) will be released after receiving a satisfactory Progress Report along with the simple statement of account of first installment within a period of 3 months from the date of release of the first installment.

(iii) Release of Third Installment

The Third & Final Installment (20% of the grant which includes 5% of Overhead Charges) is released only after the submission and verification of the following requisite documents:-

1. Final Project Report along with the Research Papers in publishable form (Hard & Soft Copy)
2. Short Summary (Hard & Soft Copy)
3. Audited Income and Expenditure Statement of Accounts along with the GFR - 12A (copy enclosed) & Original Bills for entire project amount duly signed by the Project Director, Chartered Accountant/Finance Officer/Registrar/Principal/Director of the affiliating Institution
4. An undertaking of settlement of assets and books purchased out of the project funds.
5. The Project Director is advised to run the Project Report through authorized plagiarism software before submission to the Centre.

Accordingly, the sanctioned amount will be released in Three Installments as follows:

First Installment	Rs. 26,250-00
Second Installment	Rs. 15,750-00
Third Installment	Rs. 10,500-00

The 5% overhead charges to the affiliating institution will be released only after verification of the documents by the ICSSR - SRC.

The Project Director may re-appropriate expenditure from one head to another subject to a maximum of 10%.

4. Appointment of Project Staff and Emoluments of Project Staff

Project staff could be engaged by the Project Director on a Full/ Part-time basis during the research work as per the amount prescribed below. The duration of employment may be decided by the project director. **Selection of Field Investigator should be done with an approval of the Head of the Department/ Director/ Dean/Principal. Retrospective payment for work already done is not permissible.**

Field Investigator Rs.10,000/-p.m. (not exceeding 2.5 months).

The contingency grant may be utilized for research and office assistance, printing, stationery, computer related costs, research assistance and the field work expenses related the research work.

5. Submission of Final Report

Detailed Particulars to be submitted after the completion of the Research Project is as follows:-

a. The Project Director is required to submit a Final Report (about 60 to 80 pages) along with a brief summary (about 20 to 25 pages) to the Centre on completion of the project. The Centre may, after scrutiny of the report, request the Project Director to revise the report.

b. Both documents should be submitted in hard format (two copies of final report and ten copies of summary) and a soft copy (in pen drive).

c. The Final Report and its contents are need to be entirely original. No Segment of the work should be taken from another source without due citation and acknowledgement. The scholar is needs to be aware that plagiarism is a serious offence and will mean immediate rejection of the project and black listing of the scholar. The Project Director is advised to run the Project Report through authorized plagiarism software before submission to the Centre.

d. The ICSSR-SRC reserves the right to demand raw data, or such parts of the study as deems fit.

e. Please share a copy of the published research paper out of this Short Duration Research Project after completion of the project for documentation the same at SRC.

6. Publications out of Project

Project Director need to submit a copy of all the publications (Journal, Policy Document & Book Chapter) brought out of the project work in due course of time. The Project Director should also acknowledge the contribution of SRC in all the publications coming out of the project.

7. Obligation of the Affiliating Institution

The affiliating Institution needs to provide the requisite research infrastructure to the scholar and maintain proper accounts.

The affiliating institution shall make suitable arrangements for preservation of data such as filled in schedules, tabulation sheets, manuscripts, reports, etc. relating to the study.

The overhead charges shall be paid only after the completion of the project and on receipt of the final audited Statement of Accounts.
