General Guidelines

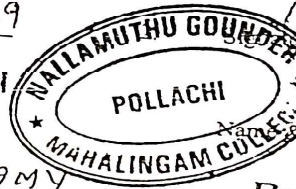


